Important Instructions

1. The State Government/ UT/ Directorate of Technical Education/ Directorate of Medical Education shall ensure that 10% of reservation for Economically Weaker Section (EWS) as per the reservation policy for admission, operational from the Academic year 2020-21 is implemented without affecting the reservation percentages of SC/ ST/ OBC/ General. However, this would not be applicable in the case of Minority Institutions referred to the Clause (1) of Article 30 of Constitution of India. Such Institution shall be permitted to increase in annual permitted strength over a maximum period of two years beginning with the Academic Year 2020-21
2. The Institution offering courses earlier in the Regular Shift, First Shift, Second Shift/Part Time now amalgamated as total intake shall have to fulfil all facilities such as Infrastructure, Faculty and other requirements as per the norms specified in the Approval Process Handbook 2020-21 for the Total Approved Intake. Further, the Institutions Deemed to be Universities/ Institutions having Accreditation/ Autonomy status shall have to maintain the Faculty: Student ratio as specified in the Approval Process Handbook. All such Institutions/ Universities shall have to create the necessary Faculty, Infrastructure and other facilities WITHIN 2 YEARS to fulfil the norms based on the Affidavit submitted to AICTE.
3. In case of any differences in content in this Computer generated Extension of Approval Letter, the content/information as approved by the Executive Council / General Council as available on the record of AICTE shall be final and binding.
4. Strict compliance of Anti-Ragging Regulation: - Approval is subject to strict compliance of provisions made in AICTE Regulation notified vide F. No. 373/Legal/AICTE/2009 dated July 1, 2009 for Prevention and Prohibition of Ragging in Technical Institutions. In case Institution fails to take adequate steps to Prevent Ragging or fails to act in accordance with AICTE Regulation or fails to punish perpetrators or incidents of Ragging, it will be liable to take any action as defined under clause 9(4) of the said Regulation.

CONTINUATION AFFILIATION ORDER

In exercise of the powers conferred upon by the Vice-Chancellor under Section 10(8) of the I.K. Gujral Punjab Technical University, VMS Institute of Management, Amritsar Road, Batala, Punjab is granted affiliation with I.K. Gujral Punjab Technical University on provisional basis, for a period of one year, for running the following courses with an intake as specified, for the session 2020-21, subject to the following terms and conditions:-

1. The institute is not authorized to start new course/increase or decrease in sanction Intake/close a course without prior approval of the University;
2. Adequate funds shall be available with the Institution to meet the financial obligations of recurring and non-recurring nature as prescribed by the university, from time to time;
3. The College shall create the necessary infrastructure as per the norms prescribed by the University/UGC/AICTE for running the above courses during the session 2020-21 and onwards.
4. All infrastructure, instructional, faculty and other facilities shall be provided as per the UGC/AICTE/University norms prescribed from time to time;
5. Teaching and other staff shall be Appointed by the institute according to the procedure, qualifications, experience and pay scales as prescribed by the UGC/AICTE/University from time to time and subject experts and nominee of the Vice chancellor of the University shall be invited in the selections vide letter No. IKGPTU/Reg./1150 Dated 13.06.2016 Issued by Registrar Office.
6. The institute shall display the information like curriculum vitae, photograph, pay-scale of all faculty and staff on the website of the institute.
7. The institute shall pay the salary of faculty and staff as per UGC/AICTE pay scale.
8. The tuition and other fees shall be charged as prescribed by the State Govt./University within the overall criteria/limits as may be laid down by the University from time to time from students.
9. Admissions shall be made according to regulations /directions and eligibility criteria of the University;
10. The Institutions shall not automatically become eligible to receive financial grant/assistance from the Central/State Govt. or any other funding agency;

11. The institution shall maintain the record and books of account in the proper form, as prescribed by the University.

12. The accounts of the institution shall be audited by Chartered Accountant or any competent person as may be decided by the University.

13. The institution shall submit the annual report to the University.


15. The institution can be visited at any time by an Officer of a UGC/AICTE/University to review the progress made by the institution in fulfillment of the conditions of affiliation.

16. The Governing Body of the Institution shall be constituted and its powers shall be defined as per the bye-laws of the University.

17. The institution shall

18. The institution shall constitute a Planning and Monitoring Board for the continuous monitoring and implementation of norms and standards of the University. There shall be an evaluation of the Institution by the University periodically as desired by the University.
19. The Institution will have an independent building and facilities as per norms of the University with a separate approach and shall have a separate Principal/Director/faculty and other facilities.
20. The University can disaffiliate the institute, if it fails to deposit the continuation affiliation fee as per schedule & non submission of continuation application form annually.
21. University has right to close the college/course or reduce the number of sanctioned seats at any time based on the inspection-report carried by the University without any notice.
22. Colleges offering Agriculture Course are required to comply with norms of Punjab State Council of Agricultural Education.


